4. We understand the terms of payment to be STRICTLY 30 DAYS NETT unless specified otherwise in writing at the discretion of the management of HI-TECH Elements (Pty) Ltd.
5. We agree that HI-TECH Elements (Pty) Ltd shall be entitled, at it's option, to bring any claim it may have against us in terms hereof, in the Magistrate Court, having jurisdiction in respect of any amount, at any time due by us in any way, arising from any credit facility granted to us in good faith, not withstanding that such cause of action may be beyond the jurisdiction of such court. We agree that HI-TECH Elements (Pty) Ltd may at it's option bring such claim in the Supreme Court of South Africa.

In the event of HI-TECH Elements (Pty) Ltd having any claim against us, in respect of any amount due by us at any time, the indebted amount shall at any time be determined & proved by a written certificate of a director of HI-TECH Elements (Pty) Ltd whose appointment as such need not be proved, such certificate shall be binding on us & shall be prima facie proof of the in debted amount.
